Background:

The following community benefits were proposed at the meeting Wednesday May 4, 2022. Committee Members have been asked to rank their top 10 priorities with 1 being the most important and 10 the least. The results will be tabulated and reviewed at the next meeting.

 - Fence at south end of the site.
 - One additional covered bicycle ramp/loop at northwest corner of the site.

 - Crosswalks at northern two pocket parks proposed.
 - Benches wherever possible.
 - Drop off USPS Mailbox.
 - Mailboxes directly in front of home instead of consolidated.
 - Sound barriers for train noise.
