Subject: Resolutions 2022-001 & 2022-002

SUMMARY & BACKGROUND:

During the June 23 meeting of the Police Advisory Commission two resolutions were considered; one requesting that the City become a member of the National Association for Civilian Oversight and Law Enforcement (NACOLE), and a second requesting that the commission be involved with the process for license plate reading devices in the city, and that prior to their installation the city would seek public participation. Chair Wolkoff has requested an update on both resolutions.

Resolution No. 2022-001, requesting the city become a member of NACOLE:

The approved resolution was provided to Council under Board and Commission – Communication during City Council’s July 12, 2022 meeting. Council took no action on this resolution.

Resolution No. 2022-002, license plate reading devices

While the Commission voted to table this item, City Council has since approved Resolution No 2022-182 opposing the installation of these devices both in the city and neighboring committees. This resolution has been previously forwarded to the Commission and the Ypsilanti Township Board of Trustees.

In addition, City Council has approved on first reading ordinance 1401, “An ordinance to prohibit the installation or use of electronic license plate scanning devices in the City of Ypsilanti”. Second Reading is scheduled for one of Council September Meeting.

City Council and Police Advisory Commission Joint Meeting

City Council has requested the commission select several dates that the joint meeting could be held. The Commission’s schedule conflicts with another meeting that requires the attendance of several Council Members.
